MESSAGE FROM THE CEO



This year I received two honors. I was appointed Visiting Research Associate at the Department of Pacific Studies at the UNSW, which I accepted with great enthusiasm. I was also invited by the United Nations Environment Program (UNEP) to attend a weeklong environmental sustainability leadership program at Tongji University in Shanghai, China, as part of the UN's program promoting the United Nations decade of Education for Sustainable Development which started in 2005. Being surrounded by the brilliant and visionary minds of dedicated people from such diverse backgrounds all working towards a sustainable future for our Asia Pacific region was a truly inspiring and motivating experience and has helped to guide the direction and focus of International Help Fund Australia. It also reinforced the enormous task ahead of us if we and our magnificent earth are to avoid a collision with total ecosystem breakdown. "Environmental Sustainable Development" means the use, conservation and enhancement of our natural resources so that the ecological

processes, on which life depends, are maintained, and the quality of life, now and into the future, is improved (Commonwealth of Australia 1992.) At International Help Fund Australia, we include in this definition 'social and cultural equity", meaning equal access to education and health services and economic opportunities. Reaching environmental sustainability requires nothing less than full community participation: government, the corporate and business world, and civil society from the local to the international level, and it means making efforts for some intangible future with no known immediate benefits save the knowledge that you are doing what is within your possibilities. As an aid organization, securing public funding for a possible future benefit, as opposed to an immediate natural disaster or refugee crisis, is indeed our greatest challenge.

No-one one understands better what becoming sustainable means than small remote islands. They have a particular challenge: isolation, high transport costs, having to import most of their needs, little land to dispose of wastes and to house growing populations, low GDP. If an island can become sustainable, it gives hope to the rest of the world. That is of course, if the international community has curbed global warming, which will submerge many of the low lying islands like Tuvalu, Kiribati, the Marshall Islands and Wallis and Fatuna, causing the entire populations of those countries to relocate. The world's first 'climate refugees' are officially from the low lying coral atolls of PNG's Cartaret Islands with the PNG government announcing in 2005 that the Islanders would be progressively relocated to Bougainville.

From a program perspective, this year has been a year of consolidation for International Help Fund Australia as we applied for tax deductibility as part of our overall strategy to becoming an AusAID accredited NGO working in cooperation with the Australian Government. Tax deductibility will allow us to secure a greater number of deductible cash donations from the Australian community which in turn will help to underwrite not just our operational costs but to significantly move ahead with our existing programs and projects and initiate new ones such as a diabetes prevention, cultural sustainability and a Child Sponsorship Program in Melanesia. This year we finished the instructional film "How to Process Plastic on Your Island", thanks to the generous support of the French Pacific Fund, the French Development Agency, Air Tahiti Nui and Australian and Chinese corporate support such as Sims Plastic, Sims E Waste and Sancon International. We developed a capacity building program in the area of environmental management and launched a pilot Ewaste program. We continue our Easter Island water sanitation program and began a desertification prevention project in continuity with our waste management program. We sent two composting toilets to the Chilean National Parks Authority for installation in their UNESCO listed world heritage national parks. Our alliances with regional freight transporters such as REEF Shipping, LAN Airlines, and Air Tahiti Nui have strengthened as have our partnerships with the Australian and regional corporate community. We look forward to greater success in the coming year.

OVERVIEW OF PROJECTS AND PROGRAMS

THE PACIFIC REGION SCRAP METAL AND PLASTIC RECYCLING AND REMOVAL PROGRAM (SCRAP).

- Following on from the success of the film "How to Process Scrap Metal on Your Island", IHFA co-produced, directed and wrote the film "How to Process Plastic on Your Island".
- The film, shot in Australia and Tahiti, is an instructional video for waste management departments on how to categorise, sort and process plastic waste in an island setting, including OH&S issues.
- The film was produced in partnership with the French High Commission, the French Development Agency and the Société Environnement Polynésien (Tahiti's Waste Management Department),
- The film was funded by the French Pacific Fund. Air Tahiti Nui also provided freight and tickets for the film crew. Sims Plastic, Sims E Waste and Sancon International provided technical assistance. The Plastic and Chemical Industry of Australia provided IHFA with learning materials which are to be distributed to the Islands with each copy of the film.
- Other contributors included Faafetai Sagapolutele of the Samoan Waste Management Department, the Tahitian Ministry of Environment and Sustainable Development, and the Secretariat of the Pacific Region Environment Program.
- The film will be distributed to Environment Ministries and Waste Management Departments of the Pacific Islands.

EQUIPMENT SUITABLE FOR PROCESSING PLASTIC ON A PACIFIC ISLAND:

- IHFA conducted a survey on the islands and has identified several types of affordable equipment appropriate for baling, shredding and compacting plastic on a Pacific Island.
- The next step in our program is to procure this equipment for shipment to the islands, taking into account issues such as energy capacity and fuel costs.

WATER SANITATION

Easter Island

- IHFA sent two composting toilets to Easter Island as part of a donation to the Chilean National Parks Authority.
- The Rotaloo Maxi 2000 will be installed in the stunning new visitors centre at the UNESCO listed world heritage National Park of Rapa Nui.
- The Rotaloo 950 is to be trialed in a domestic home.
- The Maxiloo was bought with a donation from the American Easter Island Foundation. Australia's Environment Equipment donated the Rotaloo 950. Air Tahiti Nui flew the composting toilets, from Sydney to Tahiti free of charge. From there LAN Chile flew the Rotaloos onto Easter Island also free of charge.

This operation was part of IHFA's ongoing efforts to help save Easter island's drinking water supply from irreversible contamination. The Islands unlined landfill sits directly on top of the Hanga Roa aquifer. Fifty five thousand tourists a year visit the island of nearly 4,000 inhabitants but there is almost no water sanitation. Ninety five percent of the toilets are pit latrines. The fresh water aquifer at the UNESCO listed World Heritage National Park of Anakena Beach has already been closed to human consumption for this reason.

FORESTRY

Easter Island Soil Erosion

Easter Island is scene of one of the best known ecological catastrophes as a result of deforestation by the early settlers. The removal of tree cover engendered severe soil erosion which continues to this day. Of the 14,238 hectares (86% of the Island) covered with vegetation, 78% is in a state of degradation to very degraded, 206 hectares has turned to desert. Only 3,911 hectares of the whole island in a normal state. Two hundred and six hectares of Easter islands has turned to desert. A lot of this is on the tops and sides of the Rapa Nui hills. This is catastrophic for an Island the size of Rapa Nui. On the volcanic outcrop of Poike, 300 of the 1400 hectares is severely eroded with ravines 6 meters deep and 50 meters large.

In April 2006 IHFA was invited to attend the presentation of the pilot program funded by the French Pacific Fund and implemented by ONF International, the Commission for the Development of Easter Island, (CODEIPA) and other local offices. The pilot program "Sustainable Management of the Natural Resources of Rapa Nui" objectives are to restore tree cover, sustainable management of stockbreeding, and the canalization of tourists. The Chilean National Parks Authority (CONAF) launched a nursery to produce 20,000 native and Polynesian plants in the first year. But their efforts are hampered by a lack of funds and equipment need , like a grinder, to start a full scale composting program. IHFA has continued to assist CONAF and the municipality to put into place a composting program and find funding to roll out the tree planting program.

APPOINTMENT TO THE UNIVERSITY OF NEW SOUTH WALES

This year IHFA's CEO, Petra Campbell was appointed Visiting Research Associate at the University of New South Wales, which Petra pursues with great enthusiasm. This is an honorary position with the Faculty of Arts and Social Sciences, School of Sociology and International Studies, at the Department of Pacific Studies. In this new



position Petra wrote a conference paper titled "EASTER ISLAND: A Pathway to Sustainable Development" for the VII International Conference: Easter Island and the Pacific Migration, Identity and Cultural Heritage to be held at Gotland University in Sweden from the 20-25th August 2007.

UNIVERSITY COOPERATION

- Via the University of Technology of Sydney's Shopfront Community Program a team of UTS MBA students produced a fund raising strategy document for IHFA. In 2007 a new team of students is building on that work.
- The University of Western Australia has provided assistance to IHFA in the drafting of its policies.
- IHFA is currently working with UNSW to develop an environmental auditing program for the Pacific Islands.
- IHFA's board voted to adopted a capacity building program in Environmental Auditing
 and Environmental Management Systems training. The UNSW is currently accredited
 under the RABQSA International Training Provider Accreditation Scheme to provide
 training and examination in these subjects and is helping IHFA develop a tailored course
 and follow up auditing program for the Pacific Islanders.
- This program supports AusAID's current emphasis on strengthening environmental management systems in the Pacific Islands.

All revenue received during the financial year was sourced from client contributions.

Report on the Financial Report

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2007

NOTE 1: Statement of Significant Accounting Policies

The financial report is a general purpose financial report that has been prepared in accordance with Accounting Standards, including Australian Accounting Interpretations, other authoritative pronouncements of the Australian Accounting Standards Board and the Corporations Act 2001, the Charitable Fundraising (NSW) Act 1991 and it regulations.

The financial report is for International HelpFund Australia Limited as an individual entity, incorporated and domiciled in Australia. International HelpFund Australia Limited is a company limited by guarantee.

The following is a summary of the material accounting policies adopted by International HelpFund Australia in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

Basis of Preparation

Reporting Basis and Conventions

The financial report has been prepared on an accruals basis and is based on historical costs. It does not take into account changing money values or, except where stated, current valuations of non current assets. Cost is base on the fair values of the consideration given in exchange for assets.

(a) Revenue

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Grant revenue is recognised in the income statement when it is controlled. When there are conditions attached to grant revenue relating to the use of those grants for specific purposes it is recognised in the balance sheet as a liability until such conditions are met or services provided.

Donations and bequests are recognised as revenue when received unless they are designated for a specific purpose, where they are carried forward as prepaid income on the balance sheet.

Interest revenue and distribution income from investments is recognised on a proportional basis taking in to account the interest rates applicable to the financial assets

All revenue is stated net of the amount of goods and services tax (GST).

(b) Financial Instruments

Financial instruments are initially measured at cost on trade date, which includes transaction costs, when the related contractual rights or obligations exist. Subsequent to initial recognition these instruments are measured as set out below.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are stated at amortised cost using the effective interest rate method.

The director's loan is held at the option of the company to repay, when funds become available. No interest has been charged on the loan.

(c) Income Tax

No provision for income tax has been raised as International HelpFund Australia is exempt from income tax under Division 50 of the *Income Tax Assessment Act* 1997.

(d) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense. Receivables and payables in the Balance Sheet are shown inclusive of GST.

Cash flows are presented in the Cashflow Statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

(e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

(f) Comparative Figures

When required by Accounting Standards comparative figures have been adjusted to conform with changes in presentation for the current financial year.

(g) Going Concern

The financial report has been prepared on the assumption the company will be able to continue operations as a going concern. While the company's financial position as at 30 June 2007 indicates a net asset deficiency, the directors believe that the company will be able to generate sufficient funds in future to fund the operations of the company and meet repayments of the director's loans.
